### Abstract\*

The CUGC was already accredited by the European Commission as European Higher Education Institution (EHEI) with the Erasmus Charter 2014-2020.

#### Objectives:

The Guardia Civil University Centre (CUGC) is based in Aranjuez (Madrid) and was created by the Spanish Government via the Royal Decree 1959/2009 depending on the Ministry of Interior and with legal capability to impart Bologna accredited university studies at degree and post-degree level (master and doctorates) and carry out academic research related to security topics. Until now the CUGC has had more than 1,000 students.

#### Activities:

The CUGC's academic offer is available through its web page and virtual classroom in several languages and covers 2 degrees (240 ECTS), 3 Master Courses (60 ECTS) and 2 University Expert Courses (24 ECTS)

All the above mentioned training is provided in Spanish language although the CUGC Web page and its virtual classroom capabilities can provide automatic translation in several languages

The CUGC has used its Erasmus+ Charter 2014-2020 for Erasmus+ mobility in that period and now the Centre is engaged in new mobilities for students and staff for the period 2021-2027

It is expected to increase the mobility capability of the Centre in more than 50% in the new period, and also spread out good practices at higher education and active learning in security topics
